### Your shareholder communications

This letter accompanies the notice to members of the Annual General Meeting of Sureserve Group plc ("Company") to be held at 10.00am on 19 March 2019 at The Garden Room, City Of London Club, 19 Old Broad St, London EC2N 1DS.

The purpose of this letter is to seek members' consent to the Company sending or supplying documents and notices (such as our Annual Report and notices of future Annual General Meetings) ("Documents") to them in electronic form and via a website.

We believe increased use of electronic communications will deliver savings to the Company in terms of administration, printing and postage costs. The reduced use of paper and inks will also have environmental benefits. Electronic communications are also faster and more reliable than the post.

### Communications via a website

Under the provisions of the Companies Act 2006, we are required to ask you individually to confirm your agreement to the Company sending or supplying the Documents to you as a member of the Company via the Company's website at www.sureservegroup.co.uk ("Website").

If we do not receive a response to this letter from you within 28 days of the date of this letter, then you will be taken to have agreed (under paragraph 10 of Schedule 5 to the Companies Act 2006) that the Company may send or supply the Documents to you via the Website. Therefore, if you agree to the Company sending or supplying the Documents to you via the Website, you need take no further action in relation to this part of the letter.

If you would prefer to receive the Documents in paper form rather than via the Website, you will need to let us know by completing and signing Reply Slip A at the end of this letter and returning it to Link Asset Services at FREEPOST SAS, 34 Beckenham Road BR3 9ZA.

We will notify you by post when the Documents are available to access on the Website and we will provide you with:

- the address of the Website;
- the place on the Website where the Documents may be accessed; and
- details of how to access the Documents.

### **Communications in electronic form**

We are also required by the provisions of the Companies Act 2006 to ask you individually to confirm your agreement to the Company sending or supplying the Documents to you as a member of the Company in electronic form, for example by email.

If you agree to the Company sending or supplying the Documents to you in electronic form (in accordance with paragraph 6 of Schedule 5 to the Companies Act 2006), you can register at www.signalshares.com or complete and sign Reply Slip B at the end of this letter and return it to Link Asset Services at FREEPOST SAS, 34 Beckenham Road BR3 9ZA. Please also provide an email address for this purpose in the space provided on Reply Slip B.

### Your right to copies of the Documents in paper form

Even if you consent (or are deemed to have consented) to the Company sending or supplying the Documents to you via a website or in electronic form, you can request a copy of any of the Documents in paper form from us at any time. We will send the requested Documents free of charge within 21 days of your request. You can also change your instructions at any time by writing to Link Asset Services at The Registry, 34 Beckenham Road, Beckenham, Kent BR3 4TU. Alternatively you can change your communication preference at any time by logging on to www.signalshares.com.

### Our right to send or supply copies of the Documents in paper form

Please note that there may be particular circumstances in which the Company needs to send or supply Documents to you in paper form rather than by the Website or email, in which case the Company reserves the right to do so.

If the Company is required to restrict the sending or supplying of any Documents to any members within the European Economic Area ("EEA"), for example due to the local laws of the EEA country in which the particular members are resident or otherwise located, we will not be permitted to use electronic means to communicate with any members holding shares of the same class as those members within the EEA. In any such case, we will send you copies of the Documents in paper form.

We encourage you to take advantage of these new methods of communication.
